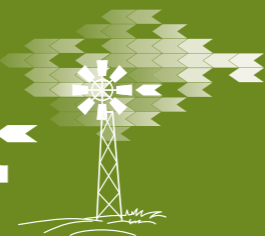

DIRECTIONS FOR USE:

Agitate well before use.

GENERAL INSTRUCTIONS:

A compound for marking vegetation.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with the chemical or used container.

STORAGE AND DISPOSAL:

Keep out of reach of children. Store in closed, original container in a well ventilated area, as cool as possible. Triple or, preferably pressure rinse containers before disposal. Add rinsings to spray tank or knapsack mix. Do not dispose of undiluted chemicals on-site.

Break, crush, puncture and bury empty containers in a local authority landfill. If not available bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, vegetation and roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS:

Do not swallow. Avoid contact with skin or eyes. Wear rubber

gloves, overalls and goggles or face shield. Wash hands with soap and water after use.

FIRST AID:

If poisoning occurs give plenty of water to drink and seek medical assistance. If skin contact occurs remove contaminated clothing and wash skin thoroughly. If in eyes, hold eyes open and flood with water for at least 15 minutes and see a doctor. Additional information is listed in the Safety Data Sheet.
